

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Transfer to Wells Fargo of the Interest Accrued by the Money Set
Aside for the Minor Accounts)

RESOLUTION NO. 06-784

1 **WHEREAS, on approximately September 28, 2006, by Resolution No. 06-628, the Legislative**
2 **Council approved the transfer of funding from the Bank of America Desert Diamond**
3 **Savings Account to Wells Fargo Bank for the establishment of the minor accounts for**
4 **the Third Per Capita Distribution; and**

5 **WHEREAS, due to discrepancies within the Resolution, the authorization given to the Treasurer**
6 **to transfer the funding was unclear and the transfer could not be made immediately**
7 **subsequent to passage of Resolution No. 06-628, as originally intended; and**

8 **WHEREAS, the discrepancies in Resolution No. 06-628 have since been resolved and the transfer**
9 **is scheduled for November 29, 2006; and**

10 **WHEREAS, in-between September 28, 2006, the date on which Resolution No. 06-628 was passed,**
11 **and November 29, 2006, the date on which the transfer will be made, interest has**
12 **accrued on the funding designated for the minors accounts; and**

13 **WHEREAS, the Nation's Treasurer has calculated the amount of interest that has accrued in the**
14 **amount of \$158,460.88; and**

15 **WHEREAS, had the transfer been made immediately, as intended, this interest would have**
16 **accrued in accounts held and managed by Wells Fargo.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
18 **authorizes the Office of the Treasurer to transfer \$158,460.88 from the Bank of**
19 **America Desert Diamond Savings Account to Wells Fargo for the interest accrued on**
20 **the Third Per Capita Payment funding designated for the minors accounts.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH. Day**
22 **of NOVEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**
