

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 06-286, "Approving Deputation Agreement between the
Bureau of Indian Affairs Law Enforcement Services and the Tohono O'odham Nation")**

RESOLUTION NO. 06-790

1 **WHEREAS, Resolution No. 06-286 approved the Tohono O'odham Nation's Deputation**
2 **Agreement with the Bureau of Indian Affairs Law Enforcement Services pursuant**
3 **to the Indian Law Enforcement Reform Act, 25 U.S.C. § 2801-2809, the Secretary of**
4 **the Interior, acting through the Bureau of Indian Affairs ("BIA"); and**

5 **WHEREAS, the Vice-Chairman of the Nation resigned his position before the Agreement was**
6 **presented to him for execution; and**

7 **WHEREAS, Resolution No. 06-286 should be amended to authorize the Chairwoman of the**
8 **Tohono O'odham Nation to execute the Agreement.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**
10 **Resolution No. 06-286 to authorize the Chairwoman of the Tohono O'odham Nation**
11 **to execute the Deputation Agreement between the Bureau of Indian Affairs Law**
12 **Enforcement Services and the Tohono O'odham Nation.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day**
14 **of DECEMBER, 2006 at a meeting at which a quorum was present with a vote of 1,082.0 FOR; -0-**
15 **AGAINST; 1,004.7 NOT VOTING; and 354.1[06] ABSENT, pursuant to the powers vested in the Council**
16 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**


