

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting and Approving the Fundraising Contribution of \$54,016.25 from the Golf**  
**Tournament Sponsored by the Desert Diamond Casinos for the Tohono O'odham Nation**  
**Cultural Center & Museum and Authorization to Expend the Budget)**

**RESOLUTION NO. 06-804**

1 **WHEREAS, the Tohono O'odham Nation recognizes the importance of promoting the**  
2 **understanding of O'odham *himdag* from historical and contemporary perspectives;**  
3 **and**

4 **WHEREAS, the Tohono O'odham Nation's Legislative Council adopted Resolution No. 2000-275**  
5 **on June 09, 2000, approving appropriations for the design, construction, staffing and**  
6 **operations of a cultural center and museum for the Tohono O'odham Nation; and**

7 **WHEREAS, the Desert Diamond Casinos held a golf tournament on April 21-22, 2006 to raise**  
8 **funds to benefit *Himdag Ki: Hekihu, Hemu, Im B I-Ha'ap*, the Tohono O'odham**  
9 **Nation Cultural Center & Museum (Cultural Center & Museum); and**

10 **WHEREAS, the Desert Diamond Casinos raised funds from participants and vendors in the**  
11 **amount of \$54,016.25 that is being donated to the Cultural Center & Museum; and**

12 **WHEREAS, the funds will help complete work undertaken prior to the opening of the Cultural**  
13 **Center & Museum.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
15 **approves and accepts the donation and contribution from the golf tournament**  
16 **fundraising benefit sponsored by the Desert Diamond Casinos on behalf of the**  
17 **Tohono O'odham Nation Cultural Center & Museum in the amount of \$54,016.25 and**  
18 **further authorizes the creation of an account for said funds to be expended in**  
19 **accordance with the attached FY 2007 budget.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's Tribal Chairwoman and any other**  
21 **designated official are hereby authorized to execute the budget, as attached hereto.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day**  
23 **of DECEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and 01 ABSENT, pursuant to the powers vested in the Council by Section**  
25 **1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**


