

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY07 Budgets for the Hickiwan District Seven Communities in the**  
**amount of \$37,319.99 per community with a total of \$261,239.95)**

**RESOLUTION NO. 06-809**

1 **WHEREAS, the Hickiwan District Administration presented their FY07 Budget to the Tohono**  
2 **O'odham Legislative Council for approval in the amount of \$846,852.52 for**  
3 **Administrative Operations from Gaming Distribution /Host Share of \$1,108,092.47;**  
4 **and**

5 **WHEREAS, the seven (7) communities (Schuchulikg, Hodai Shon Wo'o, South Hickiwan, Stoa-**  
6 **Bith, Vaya Chin, Ventana and Gehaka) will receive \$37,319.99 per community with a**  
7 **total of \$261,239.95; and**

8 **WHEREAS, the Hickiwan District Council at a special meeting on November 14, 2006 approved**  
9 **the FY07 budgets for the seven (7) communities (Schuchulikg, Hodai Shon Wo'o, South**  
10 **Hickiwan, Stoa-Bith, Vaya Chin, Ventana and Gehaka) by Resolution No. 111406-01.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
12 **the seven (7) communities of Schuchulikg, Hodai Shon Wo'o, South Hickiwan, Stoa-**  
13 **Bith, Vaya Chin, Ventana and Gehaka FY07 Budgets in the amount of \$37,319.99 per**  
14 **community with a total of \$261,239.95.**

15 **BE IT FURTHER RESOLVED that the Hickiwan District Administration Budget in the amount of**  
16 **\$846,852.52 previously approved through the Tohono O'odham Legislative Council**  
17 **Resolution combined with the total budget amount of \$261,239.95 for the seven (7)**  
18 **Hickiwan District Communities in this Resolution, budgets the entire Hickiwan**  
19 **District Gaming Distribution /Host Share in the amount of \$1,108,092.47.**

20 **BE IT FURTHER RESOLVED that any modifications regarding these district budgets shall be**  
21 **submitted to the Tohono O'odham Legislative Council Budget & Finance Committee**  
22 **for review and approval.**

23 **BE IT FINALLY RESOLVED that any modifications or amendments in the funding or funding levels**  
24 **of these district budgets shall be submitted to the Tohono O'odham Legislative**  
25 **Council Budget & Finance Committee for review and further prior approval by the**  
26 **Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
28 **of DECEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**






