1 **WHEREAS, by Resolution No. 06-735, Legislative Council approved the HICKIWAN DISTRICT**  
2 **ADMINISTRATION FY 07 BUDGET IN THE AMOUNT OF \$846,852.52 FOR ADMINISTRATIVE**  
3 **OPERATIONS; AND**

4 **WHEREAS, the HICKIWAN DISTRICT COUNCIL HAS APPOINTED A VICE-CHAIR OF THE DISTRICT AND DESIRES**  
5 **TO PAY THE VICE-CHAIR WITH FUNDS CURRENTLY ALLOCATED TO AN ADMINISTRATIVE ASSISTANT;**  
6 **AND**

7 **WHEREAS, ON NOVEMBER 27, 2006, THE DISTRICT COUNCIL APPROVED THIS CHANGE BY RESOLUTION NO**  
8 **112706-01.**

9 **NOW, THEREFORE, BE IT RESOLVED THAT THE TOHONO O'ODHAM LEGISLATIVE COUNCIL APPROVES**  
10 **AMENDMENT TO THE HICKIWAN DISTRICT ADMINISTRATION FY 07 BUDGETS RETRO ACTIVE TO**  
11 **NOVEMBER 27, 2006 TO PROVIDE A CHANGE IN PAYROLL SCHEDULE FROM ADMINISTRATIVE**  
12 **ASSISTANT TO VICE-CHAIR.**

13 **BE IT FURTHER RESOLVED THAT ALL OTHER MATTERS RELATING TO THE HICKIWAN DISTRICT ADMINISTRATION**  
14 **FY 07 BUDGET RETROACTIVE TO NOVEMBER 27, 2006 SHALL REMAIN THE SAME.**

17 **AGAINST; -0- NOT VOTING; AND [02] ABSENT, PURSUANT TO THE POWERS VESTED IN THE COUNCIL BY**  
18 **SECTION 1(d)(3) OF ARTICLE VI OF THE CONSTITUTION OF THE TOHONO O'ODHAM NATION, ADOPTED BY THE**  
19 **TOHONO O'ODHAM NATION ON JANUARY 18, 1986; AND APPROVED BY THE ACTING DEPUTY ASSISTANT**  
20 **SECRETARY - INDIAN AFFAIRS (OPERATIONS) ON MARCH 6, 1986, PURSUANT TO SECTION 16 OF THE ACT OF JUNE**  
21 **18, 1934 (48 STAT. 984).**


