

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Attorney Contract with the Law Firm of Chandler & Udall, LLP)**

**RESOLUTION NO. 06-816**

1 **WHEREAS, pursuant to Resolution No. 05-700, the Tohono O'odham Legislative Council approved**  
2 **an Attorney Contract with the law firm of Chandler & Udall, LLP to review the draft**  
3 **Water Code and prepare any regulations required thereunder; and**

4 **WHEREAS, additional time is required to complete the review of the draft Water Code and any**  
5 **related regulations under the Code; and**

6 **WHEREAS, the District Water Advisory Committee proposes an Attorney Contract with the law**  
7 **firm of Chandler & Udall, LLP in the amount of \$20,000 for the period from October**  
8 **1, 2006 to September 30, 2007; and**

9 **WHEREAS, the District Water Advisory Committee's budget line item (Account No. 21-2021-810)**  
10 **has sufficient interest earned in the SAWRSA Trust Fund to provide funding of the**  
11 **Attorney Contract in the amount of \$20,000; and**

12 **WHEREAS, the Water Resources, Domestic Affairs and Budget and Finance Committees of the**  
13 **Tohono O'odham Legislative Council recommend approval of an Attorney Contract**  
14 **with the law firm of Chandler & Udall, LLP in the amount of \$20,000 for the period**  
15 **from October 1, 2006 to September 30, 2007.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
17 **the Attorney Contract with the law firm of Chandler & Udall, LLP for the period from**  
18 **October 1, 2006 to September 30, 2007 in the amount of \$20,000.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
20 **Nation's Officials, to wit: the Chairwoman and any designated official are authorized**  
21 **to negotiate and execute the Attorney Contract, provided however, that any**  
22 **amendments affecting the funds or funding levels of the budget, shall be submitted**  
23 **to Tohono O'odham Legislative Council for approval.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day**  
25 **of DECEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,344.25 FOR; -0-**  
26 **AGAINST; 96.55 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
30 **Stat. 984).**
