

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with the Law Firm of Brauchli & Brauchli, P.C.)**

RESOLUTION NO. 06-817

1 **WHEREAS, pursuant to Resolution Nos. 05-641 and 06-415, the Tohono O'odham Nation (the**
2 **"Nation") entered into an Attorney Contract with the law firm of Brauchli & Brauchli,**
3 **P.C. (the "Attorneys") to provide legal representation to the Nation related to the**
4 **Cultural Center/Museum Project for fiscal year 2006; and**

5 **WHEREAS, the Attorney Contract expired on September 30, 2006; and**

6 **WHEREAS, *Himdag Ki: Hekiĥu, Hemu, Im BI-Ha'ap*, the Tohono O'odham Nation Cultural Center**
7 **& Museum (Cultural Center & Museum) requires continuing legal representation as**
8 **it becomes operational, relative to cooperative agreements, contracts and**
9 **agreements, liability, fundraising, and other issues related to its operations and**
10 **governance; and**

11 **WHEREAS, the Cultural Center & Museum recommends the engagement of the Attorneys for the**
12 **foregoing legal services; and**

13 **WHEREAS, attached hereto is an Attorney Contract with the Attorneys in the amount of \$15,000**
14 **for the period ending September 30, 2007; and**

15 **WHEREAS, the Cultural Preservation, Domestic Affairs and Budget & Finance Committees**
16 **recommend approval of the Attorney Contract.**

17 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 18 **1. The Legislative Council approves an Attorney Contract with the law firm of**
19 **Brauchli & Brauchli, P.C. in the amount of \$15,000 for fiscal year 2007, retroactive**
20 **to October 1, 2006 to September 30, 2007.**
- 21 **2. Funding of the Attorney Contract shall be provided from the Cultural Affairs &**
22 **Museum Operational Budget (Account No. 01-1508-810).**
- 23 **3. The Chairwoman of the Nation is authorized and directed to execute the Attorney**
24 **Contract.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
26 **of DECEMBER, 2006 at a meeting at which a quorum was present with a vote of 1,586.85 FOR; -0-**
27 **AGAINST; 853.95 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
29 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**


