

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Department of Health and Human Services, Division
of Behavioral Health, FY2007 Youth Suicide Prevention GRANT AWARD)**

RESOLUTION NO. 06-825

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health**
2 **provides substance abuse, mental health, and prevention services; and**

3 **WHEREAS, the Division of Behavioral Health submitted an application to the U.S. Department**
4 **of Health and Human Services/Center for Mental Health Services for a Youth Suicide**
5 **Prevention Program grant to provide programs to reduce youth suicides and**
6 **increase wellness, on May 6, 2006; and**

7 **WHEREAS, the Notice of Award was received for Fiscal Year 2007 on October 1, 2006 in the**
8 **amount of \$400,000 for the first year of a three-year grant; and**

9 **WHEREAS, of the total grant amount of \$400,000 this budget reflects the current indirect costs**
10 **of 17.98%; and**

11 **WHEREAS, the Youth Suicide Prevention grant for \$400,000 for Year One of the grant is hereby**
12 **submitted for review and approval by the Tohono O'odham Legislative Council.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

14 **1. It hereby approves and authorizes expenditures in accordance with the FY 2007**
15 **for a Youth Suicide Prevention grant, and attached budget in the amount of**
16 **\$400,000 for the first year of a three year grant.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
18 **Nation's Official, to wit: the Chairwoman, and any designated official are authorized**
19 **to negotiate and execute the grant, provided however, that any amendments/**
20 **modifications affecting the funds or funding levels of the grant shall be submitted for**
21 **further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH. Day**
23 **of DECEMBER, 2006 at a meeting at which a quorum was present with a vote of 1,928.85 FOR; -0-**
24 **AGAINST; 511.95 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1(d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**


