(Approving a \$500.00 Holiday Bonus for all permanent and temporary Employees,
Appointed Directors, Elected Officials and Judges of the Tohono O'odham Nation)**

RESOLUTION NO. 06-833

1 **WHEREAS, the Legislative Council has received petitions for a Holiday Bonus from the Nation's**
2 **Employees; and**

3 **WHEREAS, at the Tohono O'odham Legislative Council session held in December 2006 the**
4 **Holiday Bonus petitions were presented and discussed.**

5 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
6 **approves a \$500.00 Holiday Bonus for the Nation's employees, appointed directors,**
7 **elected officials, and judges.**

8 **BE IT FINALLY RESOLVED that the amount of \$752,857.50 is hereby appropriated with \$376,428.75**
9 **to come from Surplus and \$376,428.75 will come from Gaming Savings.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
11 **of DECEMBER, 2006 at a meeting at which a quorum was present with a vote of 1,853.6 FOR; 587.2**
12 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
13 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
14 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
16 **18, 1934 (48 Stat. 984).**
