

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Modification #1/amendment #2 for the Baboquivari District Budget)**

RESOLUTION NO. 06-838

1 **WHEREAS, at a regular scheduled meeting of the Baboquivari District held on December 9,**
2 **2006, at which a quorum was present; and**

3 **WHEREAS, the matter of modifying and amending the amount and justification of the District's**
4 **line items DONATION/CONTRIBUTION and BUILDING MATERIALS were discussed;**
5 **and**

6 **WHEREAS, the Council did approve to modify the line items as follows:**

15 **by the Nation and/or its programs" to "Monetary contributions, donations, and gifts**
16 **provided by the Nation, District and/or its programs to individuals and/or other**
17 **funds approved by the District Council"; and**

18 **WHEREAS, the amendment of \$14,000.00 does not affect the District's overall budget of**
19 **\$517,035.62.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **District budget modification #1/amendment #2, to modify line item 727.32-Building**
22 **Materials by subtracting \$14,000.00 and adding to line item 852.32-**
23 **Donation/Contribution for an amended amount of \$19,000.00, and the justification**
24 **amendment of line item 852.32-Donation/Contribution to read from "Montetary**
25 **contributions provided by the Nation and/or its programs" to "Monetary**
26 **contributions, donations and gifts provided by the Nation, District and/or its**
27 **programs to individuals and/or other funds approved by the District Council" and**
28 **the amendments will not affect the total amount of the District budget of**
29 **\$517,035.62.**

30 **BE IT FURTHER RESOLVED, that any changes in the justifications, additions and/or the transfer**
31 **of funds between budget line items are to be reviewed and approved by the Tohono**
32 **O'odham Legislative Council.**
