

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Override of Vetoed Resolution No. 06-818, "Repealing Papago Law and Order Code Chapter One and Ordinance No. 01-89, and Enacting and Codifying Tohono O'odham Code Title 6, Chapter 1, Courts and Procedures")**

**FAILED**  
**RESOLUTION NO. 06-845**

1 WHEREAS, during the December 08, 2006 General Session of the Tohono O'odham Legislative  
2 Council, the Council did pass Resolution No. 06-818, "Repealing Papago Law and  
3 Order Code Chapter One and Ordinance No. 01-89, and Enacting and Codifying  
4 Tohono O'odham Code Title 6, Chapter 1, Courts and Procedures"; and

5 WHEREAS, upon presentation of Resolution No. 06-818 to the Chairwoman of the Tohono  
6 O'odham Nation, she did disapprove thereof and returned it to the Council with her  
7 objections in accordance with the provisions of Article VII, Section 5 of the  
8 Constitution of the Tohono O'odham Nation; and

9 WHEREAS, during the December 27, 2006 Special Session, the Chairwoman presented to the  
10 Legislative Council her justification in vetoing Resolution No. 06-818, a copy of which  
11 is attached hereto; and

12 WHEREAS, the Legislative Council reviewed the Chairwoman's objections and after  
13 consideration, again voted to pass Resolution No. 06-818.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
15 override the Chairwoman's veto by a vote of two-thirds of the votes cast in accordance  
16 with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham  
17 Nation.

18 The foregoing Vetoed Resolution was presented to the Tohono O'odham Legislative Council on the  
19 27<sup>TH</sup> day of DECEMBER, 2006 at a meeting at which a quorum was present, and by a vote of 1,173.55  
20 FOR; 1,267.25 AGAINST; -0- NOT VOTING; and [01] ABSENT, failed to pass because it did not receive  
21 a majority of two-thirds (2/3) [1,627.20] of the votes cast as required by Section 5 of Article VII of  
22 the Constitution of the Tohono O'Odham Nation.
