

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Legislative Order No. 05-300, "Certification of Legislative Committee Officers,"**  
**to Certify Housing Committee Chairperson)**

**LEGISLATIVE ORDER NO. 06-849**

1 **WHEREAS, on November 28, 2006, Legislative Council Representative Delma Garcia resigned**  
2 **from office, thereby leaving a vacancy on the Legislative Housing Committee; and**

3 **WHEREAS, prior to her resignation, Representative Garcia served as Chairperson of the**  
4 **Legislative Housing Committee; that office therefore became vacant; and**

5 **WHEREAS, individual Legislative Council standing committees are empowered to caucus and**  
6 **elect committee officers (Legislative Rules of the Tohono O'odham Legislative**  
7 **Council, Article XII, Section 3.J.); and**

8 **WHEREAS, the Housing Committee did caucus on December 20, 2006, and did elect**  
9 **Representative Barbara Salvicio as its Chairperson.**

10 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**  
11 **certifies Representative Barbara Salvicio as Chairperson of the Housing Committee**  
12 **effective immediately.**

13 **BE IT FINALLY ORDERED that Legislative Order No. 05-300, "Certification of Legislative Committee**  
14 **Officers," is hereby amended only to the extent that Representative Barbara Salvicio**  
15 **is certified as the Chairperson of the Housing Committee.**


16 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup>. Day of**  
17 **DECEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,261.55 FOR; -0-**  
18 **AGAINST; 179.25 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
19 **Article VI, Section 1 (a) and (b) of the Constitution of the Tohono O'Odham Nation, adopted by the**  
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
22 **18, 1934 (48 Stat. 984).**
