

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing San Xavier District to Enter Into an Intergovernmental Agreement With the
Regional Transportation Authority for San Xavier Mission Plaza Pedestrian Enhancements)

RESOLUTION NO. 07-009

1 **WHEREAS, San Xavier District has negotiated an Agreement with the Regional Transportation**
2 **Authority, a subdivision of the state of Arizona which consists of all members of the**
3 **Pima Association of Governments and is organized under A.R.S. §48-5301 et seq.; and**
4 **WHEREAS, under the Agreement the Regional Transportation Authority will provide funding in**
5 **the amount of \$436,000.00 to San Xavier District, and San Xavier District will be**
6 **responsible for all project implementation including contracting, design,**
7 **construction, maintenance, operation, financial management and reporting; and**
8 **WHEREAS, the Agreement is for a project entitled "San Xavier Mission Plaza Pedestrian**
9 **Enhancements," which will address traffic and pedestrian safety concerns at the San**
10 **Xavier Mission Plaza by constructing sidewalks, crosswalks, traffic barriers, a**
11 **designated bus drop-off area, additional handicapped parking spaces, new gravel for**
12 **the parking lots, an oasis feature with street furniture and shade trees, and new signs;**
13 **and**
14 **WHEREAS, the San Xavier District Council has approved the project and has authorized the San**
15 **Xavier District Chairman to enter into the Agreement; and**
16 **WHEREAS, the Agreement is an Intergovernmental Agreement and requires the approval of the**
17 **Legislative Council pursuant to Article VI, Section 1(f) of the Constitution of the Tohono**
18 **O'odham Nation; and**
19 **WHEREAS, the Natural Resources Committee has reviewed the proposal and the Agreement, and**
20 **recommends that the Legislative Council authorize the San Xavier District to enter**
21 **into the Agreement and to be the Lead Agency, as described in the Agreement.**
22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
23 **the Intergovernmental Transportation Funding Agreement Between the Regional**
24 **Transportation Authority of Pima County and the San Xavier District of the Tohono**
25 **O'odham Nation for Design and Construction of Improvements to San Xavier Mission**
26 **Plaza Pedestrian Enhancements substantially in the form attached hereto and**
27 **authorizes San Xavier District to enter into the Agreement and to receive and expend**
28 **the funds.**

1 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council authorizes the
2 **Chairwoman of the Nation to sign the concurrence of the Nation to the Agreement.**

3 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council, by authorizing San Xavier
4 **District to enter into the Agreement, intends that all responsibility and liability,**
5 **including financial liability, related to this project and the Agreement shall remain**
6 **with San Xavier District, and no responsibility or liability, including financial liability,**
7 **shall fall upon the Tohono O'odham Nation.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
9 **of JANUARY, 2007 at a meeting at which a quorum was present with a vote of 1,917.7 FOR; 186.7**
10 **AGAINST; 336.4 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
11 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
12 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
13 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
14 **Stat. 984).**


