

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting and approving a cash donation from the Friends of Tohono O'odham Libraries**  
**to assist in buying a bookmobile for the Venito Garcia Library and Archives )**

**RESOLUTION NO. 07-019**

1 **WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia**  
2 **Library and Archives, the library agency for the Tohono O'odham Nation; and**

3 **WHEREAS, the Venito Garcia Library and Archives is charged with library development for the**  
4 **Tohono O'odham Nation; and**

5 **WHEREAS, a grant has been received (Institute of Museum and Library Services, Native American**  
6 **Library Services Enhancement Grant No. NG-03-06-0270-06) to expand library services**  
7 **with a bookmobile project; and**

8 **WHEREAS, the Friends of Tohono O'odham Libraries have given \$10,000.00 to be used only for**  
9 **buying a bookmobile, included in the grant budget for that purpose.**

10 **NOW, THEREFORE ,BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**  
11 **approves the cash donation of \$10,000.00 from the Friends of Tohono O'odham**  
12 **Libraries as per the attached letter to be used for the sole purpose of buying a**  
13 **bookmobile as per the attached budget (along with grant funding from the**  
14 **Enhancement Grant No. NG-03-06-0270-06).**

15 **BE IT FINALLY RESOLVED that Tohono O'odham Nation Officials, to wit: the Chairwoman and any**  
16 **designated Official are hereby authorized to negotiate and execute, provided,**  
17 **however, that any amendments affecting the funds shall be submitted for further**  
18 **approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
20 **of JANUARY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
