

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Support & Approval of the Tohono O'odham Utility Authority Fiber Optic Cable to AFC Site,**  
**North Komelik Community, Sif Oidak District)**

**RESOLUTION NO. 07-021**

1 **WHEREAS, by Resolution No. 08-70 the Nation established the Papago Tribal Utility Authority,**  
2 **now known as Tohono O'odham Utility Authority (TOUA) for purposes of constructing,**  
3 **maintaining and operating various utility systems within the Nation to be owned**  
4 **wholly by the Nation; and**

5 **WHEREAS, TOUA proposes to enhance the existing telecommunications system with the**  
6 **placement of a 12 pair fiber optic cable from the existing 48 fiber optic cable system**  
7 **to the AFC Site in North Komelik Community; and**

8 **WHEREAS, TOUA has identified and prioritized a project to upgrade the existing**  
9 **telecommunications facilities which is hereby described as from BIA Route 15, along**  
10 **the entrance to the Sif Oidak District Administration, to the existing AFC Cabinet Site**  
11 **within the community of North Komelik; and**

12 **WHEREAS, said project will enhance the telecommunications system for growth and future**  
13 **services made available by TOUA; and**

14 **WHEREAS, TOUA has respectfully submitted all documents and pertinent information (attached**  
15 **hereto and incorporated herein by reference) for uses consistent with the authorized**  
16 **purposes of TOUA; and**

17 **WHEREAS, the proposed TOUA Fiber Optic Cable to AFC Site will be of substantial benefit to the**  
18 **community of North Komelik, Sif Oidak District and their respective members; and**

19 **WHEREAS, the Sif Oidak District Council supported and approved the proposed project by**  
20 **enacting Resolution No. 11-06-06; and**

21 **WHEREAS, the Natural Resources Committee reviewed the proposed project on November 30,**  
22 **2006 and by consensus recommends approval thereof by the Tohono O'odham**  
23 **Legislative Council.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
25 **support and approve the TOUA Fiber Optic Cable to AFC Site, North Komelik**  
26 **Community, Sif Oidak District and related facilities in the location (as more fully**  
27 **described in the attached map and referenced supporting documents) and**  
28 **construction by TOUA or its designated subsidiaries for uses consistent with the**  
29 **authorized purposes of TOUA.**
