

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Information and Technology Budget Amendment No. 2
from use of Revenue Funds in the amount of \$28,654.92)

RESOLUTION NO. 07-027

1 **WHEREAS, pursuant to Legislative Council Resolution 97-082, the Department of Information**
2 **and Technology ("DoIT") was created and established under the General Support**
3 **Services also known as the Administrative Support Offices, to provide consultation**
4 **and support to the Executive Office and Departments for information technology**
5 **solutions that will increase align its technology with common business processes; and**

6 **WHEREAS, per Resolution 05-081, "Approving the Creation of a Dedicated Revenue Account for**
7 **the Deposit of Funds Received by the Tohono O'odham Nation's Department of**
8 **Information and Technology (DoIT)," stated that the objective is to "seek funding**
9 **from outside sources to enhance its ability to meet its goal and reduce the Nation's**
10 **financial commitment for its salaries and operations" ; and**

11 **WHEREAS, per Resolution 05-081 a program Revenue Account (01-1022-411) was established for**
12 **the deposit of these funds, and all funds obtained by the DoIT from outside sources**
13 **other than the Nation shall be deposited. It also states that the DoIT will expend**
14 **funds in the dedicated revenue account for salaries and operational purposes**
15 **consistent with budget approved by the Tohono O'odham Legislative Council.**

16 **WHEREAS, during Fiscal Year 2006 the DoIT deposited revenue in the amount of \$28,654.92 from**
17 **providing technical services to on reservation clients and will be added for a total**
18 **budget amendment of \$28,654.92; and**

19 **WHEREAS, the Legislative Committee of Budget and Finance, and the Executive Office of the**
20 **Chairwoman, recommend approval of the Budget Amendment No. 2 with**
21 **corresponding budget.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 23 **1. Approves the attached DoIT Budget Amendment No. 2 for the purpose of**
24 **expending funds in the dedicated revenue account for salaries and operational**
25 **purposes consistent with budget approved by the Tohono O'odham Legislative**
26 **Council.**



1 2. Authorizes the transfer and expenditure of the funds in the Revenue Account (01-
2 1022-411), in the DoIT FY07 Budget in the amount of \$28,654.92 in accordance
3 with the budget attached hereto.

4 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council approves the Tohono
5 O'odham Nation official, to wit: the Chairwoman and any designated official is hereby
6 authorized to administer the budget, provided however, that any amendments
7 affecting the funds or funding levels of the budget shall be submitted for further prior
8 approval by the Tohono O'odham Legislative Council.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day
10 of JANUARY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-
11 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
12 Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
13 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
15 18, 1934 (48 Stat. 984).


