

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Budget Modification/Amendment #1 to the Advocate Program FY2007 Budget)

RESOLUTION NO. 07-028

1 **WHEREAS, the Advocate Program wishes to make changes in its personnel positions to better**
2 **address the Program's increasing demands for legal services; and**

3 **WHEREAS, the Advocate Program has presented a Budget Modification detailing the changes**
4 **needed to fund these positions and the Program has adequate base funding to**
5 **accomplish these changes; and**

6 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee have each**
7 **reviewed the Budget Modification/Amendment #1 to the Advocate Program FY07**
8 **Budget.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
10 **Budget Modification/Amendment #1 to the Advocate Program FY2007 as follows:**

- 11 **1. The addition and funding of the newly created position of Advocate Program**
12 **Administrator.**
- 13 **2. The freezing of the Chief Advocate position and of one of the Program's two**
14 **Senior Supervising Advocate positions.**
- 15 **3. The elimination of the position of Assistant Chief Advocate.**
- 16 **4. The addition and funding of two permanent part-time (20+ hours per week)**
17 **Advocate Attorney II positions.**
- 18 **5. The addition and funding of one permanent full-time Advocate Attorney II**
19 **position.**

20 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves and authorizes**
21 **the Budget Modification/Amendment #1 to the Advocate Program FY2007.**

22 **BE IT FINALLY RESOLVED that any amendments affecting the funding levels of this budget shall**
23 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10th Day**
25 **of JANUARY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**


