

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the One Stop Division Bureau of Indian Affairs –477 Budget FY 2007/**  
**Amendment #1 to Resolution #06-178 and Resolution #06-179)**

**RESOLUTION NO. 07-035**

1 **WHEREAS, the Department of Labor and Employment Assistance Program from the Master 638**  
2 **Contract has been merged under the Tohono O'odham Nation's 477 Program and**  
3 **these budgets are developed with final allocation in the amount of \$899,698.34**  
4 **beginning October 1, 2006 and ending continuing until all funds are expired; and**

5 **WHEREAS, the Department of Labor Comprehensive Service Plan Budget was approved with**  
6 **Resolution Number 06-178 and the Department of Labor Supplemental Youth Service**  
7 **Budget was approved with Resolution Number 06-179, combines these funding**  
8 **streams in this modification under the rules of 477; and**

9 **WHEREAS, the 477 Program has been developed with the Native Employment Works Program**  
10 **and the Arizona Department of Economic Security funding to promote smooth**  
11 **transitional services for clients with an effective staff cost share to promote de-**  
12 **centralized services; and**

13 **WHEREAS, the 477 Program has been approved for a new organizational chart and new job**  
14 **descriptions to identify responsibilities of various staff and components to the 477**  
15 **Program that will increase the current staff size of 14 to 21 staff members with**  
16 **reclassified and new positions offered; and**

17 **WHEREAS, the 477 Program has implemented new employee assignments and will retro pay all**  
18 **staff positions effective October 1, 2006, when the 477 program was approved and**  
19 **implemented; and**

20 **WHEREAS, the 477 Program is requesting to be further known as the Education Department One**  
21 **Stop Division.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
23 **approve the FY 2007 Budget Amendment #1 merging approved budgets under**  
24 **Resolution Number 06-178 and Resolution Number 06-179 with the approved name**  
25 **of the Education Department One Stop Division with a new organizational chart and**  
26 **new positions and with staff reclassification positions, retro effective October 1, 2006.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
28 **Nation's Officials, to wit; the Chairwoman and any official appointed designee is**  
29 **hereby authorized to execute the contracts and plans, provided however, that any**  
30 **amendment affecting the funding or funding levels of this contract shall be**  
31 **submitted for further prior approval by this Council.**


