

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the One Stop Division Department of Health & Human Services – Native
Employment Works PY 06 Budget Modification/Amendment #1)

RESOLUTION NO. 07-036

1 **WHEREAS, the Department of Health & Human Services – Native Employment Works was**
2 **developed with final allocation in the amount of \$150,868.00 beginning July 1, 2006**
3 **and ending June 30, 2008; and**

4 **WHEREAS, the Department of Health & Human Service – Native Employment Works has been**
5 **developed with the 477 project to promote smooth transitional services for clients**
6 **with an effective staff cost share to promote de-centralized services; and**

7 **WHEREAS, the Department of Health & Human Services – Native Employment Works has been**
8 **approved for a new organizational chart and new job descriptions moving the**
9 **current staff from 14 to 21 total that will identify responsibilities of various staff and**
10 **components to the 477 Program; and**

11 **WHEREAS, the Department of Health & Human Services – Native Employment Works has**
12 **implemented new employee assignments and will retro pay all staff positions**
13 **effective October 1, 2006; and**

14 **WHEREAS, the Department of Health and Human Services – Native Employment Works is**
15 **requesting to be further known as the Education Department One Stop Division; and**

16 **WHEREAS, the Department of Health and Human Services – Native Employment Works has been**
17 **approved through TOLC and the Department of Health and Human Services to merge**
18 **into the 477 program, but funding timelines did not allow the fiscal component to**
19 **merge. On October 1, 2007 Native Employment Works will merge the fiscal**
20 **component with the 477 program.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
22 **approve the Budget Modification/Amendment #1 of the Department of Health &**
23 **Human Services – Native Employment Works budget with the proposed name change**
24 **of the Education Department One Stop Division with a new organizational chart and**
25 **increased staff positions and staff reclassification positions, retro effective October**
26 **1, 2006.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation's Officials, to wit; the Chairwoman and any official appointed designee is**
29 **hereby authorized to execute the contracts and plans, provided however, that any**






