2 **allocation in the amount of \$271,069.00 beginning July 1, 2006 and ending June 30,**
3 **2008; and**
- 4 **WHEREAS, the Department of Economic Security – State of Arizona Budget & Contract**
5 **Modification/Amendment #2 final allocation in the amount of \$358,355.00 beginning**
6 **July 1, 2006 and ending June 30, 2008; and**
- 7 **WHEREAS, the Department of Economic Security – State of Arizona has been developed with the**
8 **477 project to promote smooth transitional services for clients with an effective staff**
9 **cost share to promote de-centralized services; and**
- 10 **WHEREAS, the Department of Economic Security – State of Arizona has been approved for a new**
11 **organizational chart and new job descriptions with an increase of staff from 14 to 21**
12 **that will to identify responsibilities of various staff and components to the 477**
13 **Program; and**
- 14 **WHEREAS, the Department of Economic Security – State of Arizona has implemented new**
15 **employee assignments and will retro pay all staff positions effective October 1, 2006;**
16 **and**
- 17 **WHEREAS, the Department of Economic Security – State of Arizona budget has new line items**
18 **created in 610.00 Salaries, 620.00 Fringe Benefits and 750.00 Capital Equipment; and**
- 19 **WHEREAS, the Department of Economic Security – State of Arizona is requesting to be named the**
20 **Education Department One Stop Division.**
- 21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
22 **approve the Budget Modification/Amendment #2 of the Department of Economic**
23 **Security – State of Arizona budget with the approved name change to the Education**
24 **Department One Stop Division with a new organizational chart and increased staff**
25 **listing from 14 to 21 with and staff reclassification positions, retro effective October**
26 **1, 2006 and the creation of line items 610.00 Salaries, 620.00 Fringe Benefits and**
27 **750.00 Capital Equipment.**
- 28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
29 **Nation's Officials, to wit; the Chairwoman and any official appointed designee is**
30 **hereby authorized to execute the contracts and plans, provided however, that any**


