

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 07 budget amendment No. 1 for Ranger budget 638 BIA contract to
establish new line item 723 for uniforms)**

RESOLUTION NO. 07-038

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**
2 **Corrections Programs under the 638 BIA Master Contract; and**

3 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) is amending the FY 07**
4 **Ranger budget by moving uniform allowance out of salary line item 10-1092-610.70;**
5 **and**

6 **WHEREAS, TONPD is requesting to create a new line item under 723 - uniforms for the uniform**
7 **allowance for those individuals that are eligible to receive the uniform allowance;**
8 **and**

9 **WHEREAS, the changes will not change the budget amount but will create a new line item in**
10 **operational.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
12 **hereby accepts, approves and authorizes Budget Amendment No. 1 for FY 07 Ranger**
13 **Budget 638 and approves the addition of the new line item 723 - uniforms.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairwoman is hereby authorized to**
15 **execute the budget provided and that any amendments affecting the funding or**
16 **funding levels of this budget shall be submitted for approval to the Tohono O'odham**
17 **Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH. Day**
19 **of JANUARY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(2)&(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
