(Approving FINAL FY2007 Apportionment of Gaming Revenues to Districts by Equal Distribution)**

RESOLUTION NO. 07-064

1 WHEREAS, pursuant to Tohono O'odham Legislative Council did approve Resolution No.06-509  
2 approving the initial apportionment of Gaming Revenues with the available gaming  
3 revenue received to date at time of presentation; and

4 WHEREAS, the Office of the Treasurer has received final gaming revenue amounts and presents  
5 to the Tohono O'odham Legislative Council final gaming distribution figures and  
6 allocates the final distribution equally among the eleven Districts; and

7 WHEREAS, the Office of the Treasurer has presented the final figures to the Budget & Finance  
8 Committee; and

9 WHEREAS, the Office of the Treasurer allocates the following final figures listed in Column 4 for  
10 each District;






