2 **Council Winter Session in Washington, D.C. on February 26 - 28, 2007; and**

3 **WHEREAS, the Tohono O'odham Nation is a long-time member in good standing with the National**
4 **Congress of American Indians; and**

5 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to continue its participation in**
6 **the National Congress of American Indians.**






