

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 07 Bureau of Indian Affairs savings budget under the Nation's**  
**P.L. 93-638 Master Contract)**

**RESOLUTION NO. 07-086**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Bureau of Indian Affairs under a P.L. 93-638 Master Contract; and**

3 **WHEREAS, in 2005, the Nation negotiated a P.L. 93-638 Master Contract with the Bureau of**  
4 **Indian Affairs which remains in effect; and**

5 **WHEREAS, the Executive Branch has developed the following Realty Office savings budget for**  
6 **a BIA Master Contract funded function effective October 1, 2006 to September 30,**  
7 **2007; and**

8 **WHEREAS, the Executive Office will apply Realty Office Program savings from FY2005 and**  
9 **FY2006 for the operations and salaries of a FY2007 Realty Office savings budget in the**  
10 **total amount of \$39,354.68; and**

11 **WHEREAS, it is anticipated that any funds appropriated for FY2007 may be available at a future**  
12 **date but have not been identified or approved through the FY2007 appropriation.**

13 **NOW ,THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council approves**  
14 **the BIA P.L. 93-638 contract savings budget for a direct savings amount of \$32,974.18**  
15 **and an indirect savings amount of \$6,380.50 for a total of \$39,354.68 for the time**  
16 **period of October 1, 2006 to September 30, 2007.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
18 **O'odham Nation's Official, to wit: the Chairwoman and any designated official are**  
19 **authorized to administer the budget provided however, that any amendments**  
20 **affecting the funds or funding levels of the contract P.L. 93-638 shall be submitted**  
21 **for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>. Day**  
23 **of FEBRUARY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section**  
25 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**


