

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Reaffirming Appointment of Gloria Ramirez to the NCAI Workgroup on Reporting,
Accountability and Auditing and Appointing Marlene Saraficio as the Nation's Alternate)**

RESOLUTION NO. 07-091

1 **WHEREAS, the National Congress of American Indians (NCAI) has formed four national**
2 **workgroups comprised of tribal leaders to advise and work with the Bureau of Indian**
3 **Affairs (BIA) on issues affecting Indians nationwide; and**

4 **WHEREAS, NCAI encourages tribal leaders to continue their strong participation and to have a**
5 **voice on important national issues and the Tohono O'odham Nation wishes to do the**
6 **same; and**

7 **WHEREAS, there is a workgroup established by NCAI on Reporting, Accountability and Auditing**
8 **which will advise the BIA on how to develop a consistence reporting format which is**
9 **needed in order to identify unmet need, justify increases and show Congress**
10 **accountability in the use of funds; and**

11 **WHEREAS, the Legislative Council has previously appointed Representative Gloria Ramirez,**
12 **member of the Budget and Finance Committee for appointment to the national**
13 **workgroup representing the Tohono O'odham Nation (Resolution No. 2000-026).**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
15 **reaffirm the appointment of Representative Gloria Ramirez, member of the Tohono**
16 **O'odham Nation Legislative Council Budget and Finance Committee as the Tohono**
17 **O'odham Nation's representative on the NCAI Reporting, Accountability and Auditing**
18 **Workgroup, and appoints Representative Marlene Saraficio as Representative**
19 **Ramirez's alternate; provided that (1) these appointments shall supercede any prior**
20 **NCAI Reporting, Accountability and Auditing Workgroup appointments and (2) either**
21 **appointment reflected in this Resolution shall expire if the appointee vacates her**
22 **elected office for any reason.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
24 **of FEBRUARY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1(f)and(j) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
