

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Acceptance of the Office of Justice Program Office on Violence Against Women  
grant for a total of \$353,063.00 #2006-WE-AX-0006)**

**RESOLUTION NO. 07-098**

1 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has successfully received**  
2 **an award with the Office of Justice Program(OJP) Office on Violence Against Women**  
3 **(OVW) grant for arrest policies and enforcement of protection orders program**  
4 **funded through the US Department of Justice (DOJ) for the projected amount of**  
5 **\$353,063.00 under grant number 2006-WE-AX-0006; and**

6 **WHEREAS, the grant amount is funding for a two year period beginning October 1, 2006 thru**  
7 **September 30, 2008; and**

8 **WHEREAS, the grant also funds 3 new positions for (1) Domestic Violence Project Manager, (1)**  
9 **Tribal Advocate and (1) Victim Advocate; and**

10 **WHEREAS, TONPD has provided a budget showing the estimated cost of funding available for**  
11 **the two year period; and**

12 **WHEREAS, TONPD will only be budgeted for the remaining of FY 2007 with a total budget cost of**  
13 **\$204,758.60 and the remaining cost that will be available for FY 2008 budget will be**  
14 **\$199,758.60 for the total amount of the grant at \$353,063.00; and**

15 **WHEREAS, the TONPD request the Tohono O'odham Legislative Council to approve the**  
16 **acceptance of this grant and authorize the grant in the amount of \$353,063.00.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**  
18 **hereby accepts, approves and authorizes the implementation of the DOJ-OVW grant**  
19 **#2006-WE-AX-0006 with the effective date of October 1, 2006 through September 30,**  
20 **2008.**

21 **BE IT FURTHER RESOLVED that TONPD will be authorized to expend on the first year's budgeted**  
22 **amount of \$204,758.60 for FY 2007 and for the second year's budget for FY 2008 at the**  
23 **amount of \$199,758.60 for a total amount of \$353,063.00.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chairwoman is**  
25 **authorized to accept and execute any documentation associated with exercising the**  
26 **acceptance and implementation of agreement affecting the funding or funding**  
27 **levels of this grant shall be submitted for approval to the Tohono O'odham**  
28 **Legislative Council.**




