

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2007 Budget Amendment No. 1 for the Tohono O'odham Nation Police
Department BIA 638 Contract 10-1090 to add into Personnel the System
Administrator Position, Move Uniform Allowance out of Personnel into
Operations, and to include the Increase of the IDC rate to 19.35%)

RESOLUTION NO. 07-099

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**
2 **Corrections Programs under the 638 BIA Master Contract; and**

3 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2007 638 Law Enforcement**
4 **Budget in March of 2006 that did not include the position of Systems Administrator;**
5 **and**

6 **WHEREAS, the position of the System Administrator within the FY 2006 638 Law Enforcement**
7 **Budget was approved by the Tohono O'odham Legislative Council in June 2006 with**
8 **Resolution No. 06-398 ; and**

9 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) is amending the FY 2007**
10 **638 Law Enforcement base budget and adding the System Administrator position to**
11 **the Base Budget; and**

12 **WHEREAS, by adding the position of System Administrator into the FY 2007 638 Law**
13 **Enforcement Budget increases the Personnel Component of the Budget by**
14 **\$53,794.47; and**

15 **WHEREAS, the TONPD is also deleting Line Item 610.7 - Uniform Allowance at (\$22,400.00) out**
16 **of Personnel and is Creating New Line Item 723 - Uniforms at \$22,400.00 under**
17 **Operations; and**

18 **WHEREAS, Budget Amendment No. 1 reflects the New Indirect Cost (IDC) Rate at 19.35% from**
19 **17.98% in the amount of \$42,291.77; and**

20 **WHEREAS, Budget Amendment No. 1 changes the total amount of the FY 2007 638 Law**
21 **Enforcement Budget from \$2,745,622.13 to \$2,841,708.37 which includes the**
22 **increases within Personnel and the IDC rate.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
24 **accepts, approves, and authorizes the FY 2007 638 Law Enforcement Budget**
25 **Amendment No. 1 as follows:**

- 26 **1. Adds the position of System Administrator to the Base Budget which increases**
27 **the budget by \$53,794.47.**
28 **2. Deletes line item 610.70 – Uniform Allowance from Personnel and creates New**
29 **Line-Item 723 – Uniforms in Operations.**

- 1 3. Reflects the IDC rate change from 17.98% to 19.35% in the amount of \$42,291.77.
- 2 4. Changes the new budget total from \$2,745,622.12 to \$2,841,708.37.

3 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Vice Chairman is hereby authorized**
4 **to negotiate and execute the budget provided that any future amendments affecting**
5 **the funding or funding levels of this budget shall be submitted to the Tohono**
6 **O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
8 **of FEBRUARY, 2007 at a meeting at which a quorum was present with a vote of 2,019.8 FOR; -0-**
9 **AGAINST; 421.0 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
10 **Section 1 (d)(2)&(3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
11 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
13 **18, 1934 (48 Stat. 984).**


