

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Mr. Fernando J. Martinez Sr. to the Enrollment Committee)

RESOLUTION NO. 07-123

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**
3 **committees, boards, officers and agents (Article VI, Section 1(b) of the Constitution of**
4 **the Tohono O'odham Nation); and**

5 **WHEREAS, the Legislative Council has enacted and subsequently amended Ordinance No. 05-81,**
6 **the "Enrollment Ordinance," which established an Enrollment Committee to oversee**
7 **enrollment into membership in the Tohono O'odham Nation; and**

8 **WHEREAS, the Enrollment Ordinance provides that the Enrollment Committee "shall be**
9 **composed of five members of the Tohono O'odham Nation who are bilingual in the**
10 **O'odham and English languages" and whose members "shall be appointed by the**
11 **Chairman of the Nation, subject to the approval by the Tohono O'odham Legislative**
12 **Council" (Enrollment Ordinance, Article II, Section 1.A. and 1.B.); and**

13 **WHEREAS, Committee members "shall be appointed for terms of three years or until their**
14 **successors are appointed. The appointments of the five members shall be staggered**
15 **so that no more than two members shall be appointed or reappointed each**
16 **year."(Enrollment Ordinance, Article II, Section 1.C.); and**

17 **WHEREAS, subject to the approval by the Legislative Council, the Chairwoman of the Tohono**
18 **O'odham Nation has appointed Mr. Fernando J. Martinez Sr. to the Enrollment**
19 **Committee to fill a vacant seat; and**

20 **WHEREAS, if approved, Mr. Fernando J. Martinez Sr. would serve on the Enrollment Committee**
21 **for a three-year term commencing on January 1, 2006 and ending January 1, 2009,**
22 **provided that he would continue to serve until replaced by a successor who is**
23 **appointed in accordance with the Enrollment Ordinance.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
25 **the appointment of Mr. Fernando J. Martinez Sr. to the Enrollment Committee for a**
26 **three-year term commencing on January 1, 2006 and ending January 1, 2009, provided**
27 **that he shall continue to serve until replaced by a successor who has been appointed**
28 **in accordance with the Enrollment Ordinance.**

4 Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
5 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
6 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
7 Stat. 984).


