1	WHEREAS,	the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and
2		Corrections Programs under the 638 BIA Master Contract; and
3	WHEREAS,	the Tohono O'odham Legislative Council approved the FY 2007 Corrections budget
4		inMarch2006thatdidnotincludethepositionsforCorrectionsOfficers, Corrections
5		Sergeants; and
6	WHEREAS,	the additional positions for Corrections Officers and Corrections Sergeants within
7		the FY 2006 Corrections Budget was approved by the Tohono O'odham Legislative
8		Council in June 2006 with resolution No. 06-399; and
9	WHEREAS,	the Tohono O'odham Nation Police Department (TONPD) is amending the FY 2007
10		Corrections base budget and adding the positions of Corrections Officers (13) and
11		Corrections Sergeants (2) to the base budget; and
12	WHEREAS,	by adding the positions of Corrections Officers and Corrections Sergeants into the FY
13		2007 Corrections Budget increases the Personnel component of the Budget by
14		\$672,306.57; and
15	WHEREAS,	the TONPD Corrections is also deleting Line Item 610.7 - Uniform Allowance at
16		(\$28,000.00) out of Personnel and is creating a new line item 723 – Uniforms under
17		Operational; and
18	WHEREAS,	the TONPD Corrections is also creating new line items under Operational for Travel
19		Expense by adding line item 660 – travel expense at \$24,000.00 and 650 – Tuition &
20		Registration at \$13,411.53 and is also adding an additional amount of \$6,000.00 to line
21		the new line item 723 – uniforms for the additional positions of Corrections Officers
22		and Sergeant bringing total to \$34,000.00; and
23	WHEREAS,	Budget Amendment No.1 reflects the new Indirect Cost (IDC) rate at 19.35% from
24		17.98% in the amount of \$161,337.33; and
25	WHEREAS,	Budget Amendment No.1 changes the total amount of the FY2007CorrectionsBudget
26		from \$1,518,976.83 to \$2,424,032.26 is recurring funding under BIA 638 Corrections
27		Program and includes the increases within personnel, Operational and the IDC rate.

9	3) Creates new Operational line items 650 – Tuitions & Registration at \$13,411.53
10	660 – Travel Expense at \$24,000 and adds an additional amount of \$6,000.00 to
11	line item 723 – Uniforms for the additional positions of Corrections Officers and
12	Sergeant bringing total to \$34,000.00;
13	4) Reflects the IDC rate change from 17.98% to 19.35% in the amount of \$161,337.33
14	5) Changes the new base budget total from \$1,518,976.83 to \$2,424,032.26
