RESOLUTION NO. 07-144

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Water Resources Study**
2 **Program FY2007 BIA budget 10-5015 through Resolution 06-491, in the amount of**
3 **\$127,137.61; and**

4 **WHEREAS, the Nation's Grants and Contracts Office has identified \$37,827.76 in FY2006 carry-**
5 **forward funds; and**

6 **WHEREAS, the amended FY 2007 BIA budget 10-5015 is subject to the negotiated Indirect Cost**
7 **rate increase from 17.98% to 19.35% ; and**

8 **WHEREAS, the Water Resources Study Program is requesting that the FY2006 carry-forward, in**
9 **the amount of \$37,827.76 and the indirect cost charge of \$8,796.01, for a total of**
10 **\$46,623.77, be added the Water Resources Study Program FY2007 BIA budget 10-5015,**
11 **for a total budget of \$173,761.38; and**

12 **WHEREAS, the Water Resources Study Program is requesting that the line items 712 GAS, OIL,**
13 **and COOLANTS, 720 SUPPLIES-OFFICE, 721 SUPPLIES-OTHER, 723 UNIFORMS, 751**
14 **LEASE/RENTALS, and 770 RM EQUIPMENT be added to the Water Resources Study**
15 **Program FY2007 BIA budget 10-5015 in accordance with the budget attached hereto;**
16 **and**

17 **WHEREAS, the Water Resources Study Program FY2007 BIA budget 10-5015 has been reviewed**
18 **by the Legislative Water Resources Committee and the Budget and Finance**
19 **Committee.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
21 **hereby approves the:**

- 22 **1. Addition of FY2006 Bureau of Indian Affairs carry-forward funds and indirect**
23 **cost charge, in the amount of \$46,623.77 to the Water Resources Study Program**
24 **FY2007 BIA budget 10-5015, for a total of \$173,761.38.**
- 25 **2. Addition of the line items 712 GAS, OIL, and COOLANTS, 720 SUPPLIES-OFFICE,**
26 **721 SUPPLIES-OTHER, 723 UNIFORMS, 751 LEASE/RENTALS, and 770 RM**
27 **EQUIPMENT to the Water Resources Study Program FY2007 BIA budget 10-5015,**
28 **in accordance with the budget attached hereto.**

29 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**
30 **the Chairperson and any designated official to expend and administer the budget, as**
31 **attached, provided that any amendments affecting the funds or funding levels of the**

7 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
8 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
9 18, 1934 (48 Stat. 984).


