1 **WHEREAS, the Tohono O'odham Nation's Legislative Council approved the Cultural Center &**  
2 **Museum Native American/Native Hawaiian Museum Services grant MN-00-05-0034-05**  
3 **for \$16,690.00 through Resolution No. 05-636; and**

4 **WHEREAS, the Legislative Council approved a no cost extension by the Institute of Museum and**  
5 **Library Services to December 31, 2006 through Resolution No. 06-416; and**

6 **WHEREAS, FY 2006 had funds in the amount of \$16,690.00; and**

7 **WHEREAS, the Institute of Museum and Library Services has approved the request by the**  
8 **Cultural Center & Museum for a no cost extension from December 31, 2006 to June 30,**  
9 **2007 without any additional funding; and**

10 **WHEREAS, the Cultural Center & Museum no cost extension request has been reviewed by the**  
11 **Tohono O'odham Legislative Cultural Preservation Committee and the Budget and**  
12 **Finance Committee.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
14 **a no cost extension for the Native American/Native Hawaiian Museum Services grant**  
15 **MN-00-05-0034-05 from December 31, 2006 to June 30, 2007.**

16 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the FY 2007**  
17 **budget attached hereto and authorizes expenditures from October 1, 2006 to June 30,**  
18 **2007.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairperson and any designated official to expend and administer the budget, as**  
21 **attached, provided that any amendments affecting the funds or funding levels of the**  
22 **budget shall be submitted for further prior approval by the Tohono O'odham**  
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
25 **of MARCH, 2007 at a meeting at which a quorum was present with a vote of 1,826.0 FOR; -0-**  
26 **AGAINST; 614.8 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
30 **Stat. 984).**
