2 **quorum was present; and**

3 **WHEREAS, FY 2007 Budget Modification No. 1 was presented to the Chukut Kuk District Budget**
4 **Committee and the Chukut Kuk District Council; and**

5 **WHEREAS, the Chukut Kuk District Council did approve FY 2007 Budget Modification No. 1 by**
6 **district Resolution No. 2007-04; and**

7 **WHEREAS, Budget Modification No. 1 was presented to the TOLC Budget & Finance Committee**
8 **for review; and**

9 **WHEREAS, the TOLC Budget & Finance Committee did make recommendations which required**
10 **district council action; and**

11 **WHEREAS, the Chukut Kuk District Council did meet on February 26, 2007 and approved**
12 **amendments to Chukut Kuk Resolution No. 2007-04.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **the Chukut Kuk District FY 2007 Budget Modification/Amendment No. 1 attached**
15 **hereto and incorporated herein.**

16 **BE IT FINALLY RESOLVED that any amendments affecting the funding level of the Chukut Kuk**
17 **District FY 2007 budget shall be submitted to the Tohono O'odham Legislative Council**
18 **for prior approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH. Day**
20 **of MARCH, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**
