

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Acting Attorney General)**

RESOLUTION NO. 07-165

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "employ legal**
2 **counsel for the protection and advancement of the rights of the Tohono O'odham**
3 **Nation" (Constitution of the Tohono O'odham Nation, Article VI, Section 2(a)); and**
4 **WHEREAS, pursuant to Section 2.C. of the Statute Creating the Office of the Attorney General, as**
5 **adopted by Resolution No. 326-89, "The Attorney General shall be appointed by the**
6 **Chairman of the Nation, from among a group of no fewer than three persons qualified**
7 **for the position, nominated by the Domestic Affairs Committee of the Legislative**
8 **Council. The appointment shall become effective upon its approval by a majority of**
9 **the Legislative Council."; and**
10 **WHEREAS, Attorney General P. David Frank resigned on March 9, 2007 effective immediately;**
11 **and**
12 **WHEREAS, until Mr. Frank's replacement is hired, it is in the Nation's best interest to appoint an**
13 **Acting Attorney General; and**
14 **WHEREAS, Deputy Attorney General Jonathan Jantzen has served in the Office of the Attorney**
15 **General and is qualified to perform the functions of Acting Attorney General.**
16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
17 **appoints Jonathan Jantzen as the Nation's Acting Attorney General effective March**
18 **9, 2007 and until a qualified candidate is appointed by the Nation's Chairperson and**
19 **approved by a majority vote of the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH. Day**
21 **of MARCH, 2007 at a meeting at which a quorum was present with a vote of 1,826.7 FOR; -0-**
22 **AGAINST; 421.0 NOT VOTING; and 193.1 [07] ABSENT, pursuant to the powers vested in the Council**
23 **by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
