

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment No. 2 to add FY2006 SAWRSA carry-forward funds, in the amount of \$89,465.06, to the Water Resources Study Program FY2007 SAWRSA budget 21-1525)**

RESOLUTION NO. 07-169

1 WHEREAS, the Tohono O'odham Legislative Council approved the FY2007 Water Resources Study  
2 Program SAWRSA budget 21-1525 with Resolution 06-170, in the amount of  
3 \$773,178.78; and

4 WHEREAS, the Nation's Budget and Accounting Office has identified \$89,465.06 in FY2006 carry-  
5 forward funds; and

6 WHEREAS, the Water Resources Study Program is requesting that the FY2006 carry-forward, in  
7 the amount of \$89,465.06, be added the Water Resources Study Program FY2007  
8 SAWRSA budget 21-1525, for a total budget of \$862,643.84; and


9 WHEREAS, the Water Resources Study Program FY2007 SAWRSA budget 21-1525 has been  
10 reviewed by the Tohono O'odham Legislative Water Resources Committee and Budget  
11 and Finance Committee.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
13 the addition and authorizes the expenditure of FY2006 carry-forward funds, in the  
14 amount of \$89,465.06, to the Water Resources Study Program FY2007 SAWRSA budget  
15 21-1525, for a total budget of \$862,643.84, in accordance with the budget attached  
16 hereto.

17 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the  
18 Chairperson and any designated official to expend and administer the budget, as  
19 attached, provided that any amendments affecting the funds or funding levels of the  
20 budget shall be submitted for further prior approval by the Tohono O'odham  
21 Legislative Council.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day  
23 of MARCH, 2007 at a meeting at which a quorum was present with a vote of 2,051.8 FOR; -0-  
24 AGAINST; 389.0 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by  
25 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
28 Stat. 984).
