

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Financial Request)**

**LEGISLATIVE ORDER NO. 07-170**

1 WHEREAS, the Legislative Branch FY 2007 Budget permits the Branch officers to make  
2 contributions/donations in that amounts not to exceed \$800.00 unless the full  
3 Legislative Council gives its approval; and  
4 WHEREAS, the Legislative Branch has received a request for \$3,245.00 from Samuel Saunders to  
5 supplement their efforts to travel to Mexico City, Mexico for Educational purposes.  
6 NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby  
7 authorizes and directs the Legislative Branch Chairman to make a payment of  
8 \$3,245.00 for an trip to Mexico City, Mexico per the request from Samuel Saunders to  
9 the Tohono O'odham Legislative Council from the FY 2007 Budget Line Item 852 -  
10 Donations/Contributions.

11 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day of  
12 MARCH, 2007 at a meeting at which a quorum was present with a vote of 1,348.8 FOR; 625.2  
13 AGAINST; 466.8 NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by  
14 Article VI, Section 1(d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the  
15 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
17 18, 1934 (48 Stat. 984).
