

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Financial Request)**

**LEGISLATIVE ORDER NO. 07-172**

1 WHEREAS, the Legislative Branch FY 2007 Budget permits the Branch officers to make  
2 contributions/donations in that amounts not to exceed \$800.00 unless the full  
3 Legislative Council gives its approval; and

4 WHEREAS, the Legislative Branch has received a request for \$3,500.00 from Matthew Antone, a  
5 youth of the Tohono O'odham Nation to supplement his efforts to travel to Europe for  
6 Educational purposes.

7 NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby  
8 authorizes and directs the Legislative Branch Chairman to make a payment of  
9 \$3,500.00 for an trip to Europe per the request from Matthew Antone, a youth of the  
10 Tohono O'odham Nation to the Legislative Council from the FY 2007 Budget Line Item  
11 852 - Donations/Contributions.

12 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>. Day of  
13 MARCH, 2007 at a meeting at which a quorum was present with a vote of 2,184.5 FOR; -0- AGAINST;  
14 256.3 NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article VI,  
15 Section 1(d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
16 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
17 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
