**RESOLUTION NO. 07-178**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2007 Tohono O'odham**  
2 **Nation Fire Department budget 01-1095 with Resolution 06-210; and**

3 **WHEREAS, the Fire Department is requesting that line item 612 OCCASIONAL APPOINTMENTS be**  
4 **added to the FY2007 Fire Department budget 01-1095 and that \$15,000 be moved to**  
5 **this line item to cover the cost associated with hiring certified Firefighters on a part-**  
6 **time basis; and**


7 **WHEREAS, the FY2007 Fire Department budget 01-1095 Amendment No.1 has been reviewed by**  
8 **the Domestic Affairs Committee and Budget and Finance Committee.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
10 **Budget Amendment No.1 for the Tohono O'odham Nation Fire Department FY 2007**  
11 **budget and the addition of line item 612 OCCASIONAL APPOINTMENTS to the FY2007**  
12 **Fire Department budget 01-1095 to cover the cost associated with hiring certified**  
13 **Firefighters on a part-time basis, in accordance with the budget attached hereto.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
15 **Nation's Officials, to wit: the Chairwoman and any designated official are authorized**  
16 **to administer the budget, provided however, that any amendments affecting the**  
17 **funds or funding levels of the budget shall be submitted for further prior approval by**  
18 **the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup>. Day**  
20 **of MARCH, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section**  
22 **1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
