7 **this Nation, and does hereby order that their name(s) be deleted from the**  
8 **membership roll.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>. Day**  
10 **of APRIL, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
11 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
12 **Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation,**  
13 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
14 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
15 **Act of June 18, 1934 (48 Stat. 984).**


