

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(To amend Legislative Council Resolution No. 07-116 to Delete Two Names from the**  
**February and March 2007 "Monthly Age 18 Report" and correct the Listing to 69 Minors**  
**Turned 18 for Payment of the Third Per Capita)**

**RESOLUTION NO. 07-189**

1 **WHEREAS, the Legislative Council did adopt the Third Per Capita Revenue Allocation Plan**  
2 **("Plan") pursuant to Legislative Council Resolution No. 06-307, which authorized a**  
3 **third per capita payment subject to the review by the appropriate Bureau of Indian**  
4 **Affairs official, as required by federal regulations; and**

5 **WHEREAS, the Plan incorporated a Trust Agreement (the "Trust Agreement") with Wells Fargo**  
6 **Bank that would be established to protect the interests of minor and legally**  
7 **Incompetent persons (the "Beneficiaries") entitled to receive per capita payments; and**

8 **WHEREAS, the Trust Agreement provided that monthly the Nation's Enrollment Office shall**  
9 **prepare a listing of Beneficiaries who have attained the age of eighteen, which shall**  
10 **be called the "Monthly Age 18 Report", and which shall subsequently be approved by**  
11 **the Legislative Council thereby authorizing commencement of payments to identified**  
12 **Beneficiaries; and**

13 **WHEREAS, on March 5, 2007 the Enrollment Program presented to the Legislative Council the**  
14 **"Monthly Age 18 Report" for the months of February and March 2007 listing 71 minors**  
15 **who have reached the age of 18 and are no longer restricted Beneficiaries, and who are**  
16 **thus eligible for commencement of payments from Wells Fargo Bank of the amounts**  
17 **held in trust for the identified Beneficiaries; and**

18 **WHEREAS, due to clerical error the Enrollment Program listing presented to council had two**  
19 **duplicated names which showed a count of 71 on the listing; and**

20 **WHEREAS, Resolution No. 07-116 shall be amended to correct the error by deleting Isaelen L.**  
21 **Ortiz-Longoria, Roll No. 4280-ND-00 and Elizabeth L. Miller, Roll No. 1256-ST-88 from**  
22 **the "Monthly Age 18 Report" listing 69 non-Beneficiaries eligible for the third per**  
23 **capita payment.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves to**  
25 **amend Resolution No. 07-116 to delete Isaelen L. Ortiz-Longoria, Roll No. 4280-ND-00**  
26 **and Elizabeth L. Miller, Roll No. 1256-ST-88 and change the count to 69 non-restricted**  
27 **Beneficiaries identified in the February and March 2007 "Monthly Age 18 Report."**






