1 **WHEREAS, the Tohono O'odham Legislative Council approved amendment 1 to the Range**  
2 **Conservation and Management Program FY2007 budget 10-1513 through Resolution**  
3 **No. 07-194; and**

4 **WHEREAS, the Range Conservation and Management Program is requesting that the Legislative**  
5 **Council amend Resolution No. 07-194 and allow the language in the first whereas**  
6 **clause to read "Resolution No. 06-212" instead of "Resolution 06-491".**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**  
8 **Resolution No. 07-194 for the Range Conservation and Management Program FY2007**  
9 **budget 10-1513 and approves the language change in the first whereas clause in**  
10 **Resolution No. 07-194, to read "Resolution No. 06-212" instead of "Resolution 06-491",**  
11 **in accordance with the resolution attached hereto.**

12 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
13 **Chairperson and any designated official to expend and administer the budget, as**  
14 **attached, provided that any amendments affecting the funds or funding levels of the**  
15 **budget shall be submitted for further prior approval by the Tohono O'odham**  
16 **Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>. Day**  
18 **of APRIL, 2007 at a meeting at which a quorum was present with a vote of 2,254.1 FOR; -0- AGAINST;**  
19 **186.7 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section**  
20 **1 (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
23 **Stat. 984).**




