

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Lucy District FY 2007 – Maintenance Program Budget Amendment No. 1)**

RESOLUTION NO. 07-222

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with fiscal powers over the control**
2 **and management of Nation's funds by Article VI Section 1 (d) (2) and (3) of the**
3 **Constitution of the Tohono O'odham Nation; and**

4 **WHEREAS, Resolution No. 06-795 stipulates to San Lucy District any budget modification shall be**
5 **reviewed by the TOLC – Budget & Finance Committee for approval and that any**
6 **changes in the funding or funding levels shall be reviewed by the Budget & Finance**
7 **Committee and further approved by the Legislative Council; and**

8 **WHEREAS, the San Lucy District Council passed Resolution Number SL 02-10-07, that approved**
9 **Budget Modification number one for the Administration, Elderly, Health, and Human**
10 **Services Programs and Budget Amendment number one for the Maintenance**
11 **Program; and**


12 **WHEREAS, the Budget and Finance Committee has reviewed and approved the San Lucy District**
13 **program budget modifications and is further forwarding the San Lucy District's**
14 **Maintenance Program Amendment to the Legislative Council for approval.**

15 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves San**
16 **Lucy District's Maintenance Program Budget Amendment number one; an increase**
17 **of \$10,246.00 over the FY 2007 program budget for a new total of \$141,746.00.**

18 **BE IT FINALLY RESOLVED the San Lucy District FY 2007 Budget as a result of the Maintenance**
19 **Program Budget Amendment is hereby increased from \$2,178,750.55 to \$2,188,996.55**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH Day**
21 **of APRIL, 2007 at a meeting at which a quorum was present with a vote of 2,075.2 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and 365.6[10] ABSENT, pursuant to the powers vested in the Council by Section**
23 **1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
