9	Budget Modification number one for the Administration, Elderly, Health, and Human
10	Services Programs and Budget Amendment number one for the Maintenance
11	Program; and
12	WHEREAS, the Budget and Finance Committee has reviewed and approved the San Lucy District
13	program budget modifications and is further forwarding the San Lucy District's
14	Maintenance Program Amendment to the Legislative Council for approval.
15	NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves San
16	Lucy District's Maintenance Program Budget Amendment number one; an increase
17	of \$10,246.00 over the FY 2007 program budget for a new total of \$141,746.00.
18	BE IT FINALLY RESOLVED the San Lucy District FY 2007 Budget as a result of the Maintenance
19	Program Budget Amendment is hereby increased from \$2,178,750.55 to \$2,188,996.55
