7	WHEREAS, SWRO requests establishment of line item 750-Major Capitol Equipment to allow
8	transfer of funds to line item 750, to purchase the vehicles; and
9	WHEREAS, the changes will not change the bottom line budget amount for FY 07, nor affect the
10	scope of work.

12	hereby accepts, approves and authorizes Budget Amendment No. 1 for FY 07 Solid
13	Waste Regulatory Office and approves the addition of the new line item 750 Major
14	Capitol Equipment for the purchase of two vehicles.
