

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Legislative Council Session Broadcasts Preceding 2007 General Election)**

**LEGISLATIVE ORDER NO. 07-235**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**  
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**  
4 **Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council do not address**  
6 **whether Council sessions will be broadcast on the Nation's radio station, KOHN 91.9**  
7 **FM; and**

8 **WHEREAS, in order to avoid providing an undue advantage to candidates for public office who**  
9 **may make presentations during Council sessions, it is in the Nation's best interest not**  
10 **to broadcast Legislative Council sessions in the three weeks preceding the 2007**  
11 **general election.**

12 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that Legislative**  
13 **Council sessions shall not be broadcast on KOHN 91.9 FM during the three weeks**  
14 **preceding the May 26, 2007 general election.**

15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day of**  
16 **MAY, 2007 at a meeting at which a quorum was present with a vote of 1,566.7 FOR; 336.4 AGAINST;**  
17 **537.7 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
18 **Section 1(a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
