1 **BE IT FURTHER RESOLVED that the Chairwoman and other appropriate officers of the Tohono**
2 **O'odham Nation reduce this final determination in writing regarding each of the**
3 **foregoing applications for enrollment in accordance with Section 1(a) of Article XIII**
4 **of the Enrollment Ordinance; give notice of this Council's determination in**
5 **accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place the**
6 **names of each applicant upon the membership roll of the Tohono O'odham Nation**
7 **in accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance.**

8 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 07TH. Day**
9 **of MAY, 2007 at a meeting at which a quorum was present with a vote of 1,151.1 FOR; 692.2**
10 **AGAINST; 597.5 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
11 **Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham**
12 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
13 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
14 **of the Act of June 18, 1934 (48 Stat. 984).**
