4 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council does hereby
5 recognize that the above-named person(s) have relinquished their membership in
6 this Nation, and does hereby order that their name(s) be deleted from the
7 membership roll.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day
9 of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;
10 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article II,
11 Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted
12 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
13 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
14 18, 1934 (48 Stat. 984).


