

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 07-186 to Delete Two Names from Payment Schedule #79 Listing**  
**of the Per Capita Under the Second Per Capita Plan)**

RESOLUTION NO. 07-243

1 WHEREAS, on April 9, 2007 the Enrollment Office filed with the Tohono O'odham Legislative  
2 Council a certification of Eligible Members listing 47 adult members who are eligible  
3 for receipt of the Initial Per Capita Distribution; and

4 WHEREAS, the Tohono O'odham Legislative Council has accepted and approved Certification of  
5 Eligible Members for the Initial Per Capita Distribution; pursuant to Resolution No.  
6 97-451; and

7 WHEREAS, pursuant to Resolution No. 07-186 the Tohono O'odham Legislative Council approved  
8 per capita payment of \$2,000.00 for Julian L. Lopez, Roll No. 1470-P-89 and per capita  
9 payment of \$2,000.00 for Eli L. Manuel, Roll No. 1504-GV-92; and

10 WHEREAS, the sum of \$94,000.00 shall change to \$90,000.00 to correct the reduced amount of  
11 \$2,000.00 for each member and that the transfer of sum from the Per Capita Account  
12 to the special checking account established at Bank of America will commence  
13 payment.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves to  
15 amend Resolution No. 07-186 to delete the names of Eli L. Manuel, Roll #1504-GV-92  
16 and Julian M. Lopez, Roll #1470-P-89 from the listing and to change the Payment  
17 Schedule #79 listing to 45 names and the authorized sum to \$90,000.00 for the Second  
18 Per Capita Plan Payments.

19 BE IT FINALLY RESOLVED, that Julian M. was listed in the February 2007 Payment Schedule  
20 #77 and Eli L. Manuel was listed in the March 2007 Payment Schedule #78 and both  
21 names shall be deleted from payment schedule #79 due to duplication.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day  
23 of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;  
24 -0- NOT VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)  
25 and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
28 Stat. 984).


