1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY07 Cultural Affairs Program**
2 **budget 01-1506 with Resolution 06-210; and**

3 **WHEREAS, the Cultural Affairs Program is requesting that \$32,395 in insurance payments for**
4 **damaged equipment be added to the FY07 Cultural Affairs Program budget 01-1506**
5 **for a total of \$211,622.95; and**

6 **WHEREAS, the Cultural Affairs Program is requesting that line item 750 CAPITAL EQUIPMENT be**
7 **added to the FY07 Cultural Affairs Program budget 01-1506; and**

8 **WHEREAS, amendment 1 to the FY07 Cultural Affairs Program budget 01-1506 has been reviewed**
9 **by the Tohono O'odham Nation Legislative Cultural Preservation Committee and the**
10 **Budget and Finance Committee.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 12 **1. Approves the addition of \$32,395 in insurance payments for damaged equipment**
13 **to the FY07 Cultural Affairs Program budget 01-1506, in accordance with budget**
14 **attached hereto.**
- 15 **2. Approves the addition of the line item 750 CAPITAL EQUIPMENT to the FY07**
16 **Cultural Affairs budget 01-1506, in accordance with budget attached hereto.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the budget, as**
19 **attached, provided that any amendments affecting the funds or funding levels of the**
20 **budget shall be submitted for further prior approval by the Tohono O'odham**
21 **Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH, Day**
23 **of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,356.3 FOR; -0-**
24 **AGAINST; 84.5 NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section**
25 **1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
