

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Budget Amendment #3 to the FY2007 Office of the Treasurer Budget)**

**RESOLUTION NO. 07-249**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2007 Office of the Treasurer**  
2 **Budget pursuant to Legislative Council Resolution No. 06-210; and**  
3 **WHEREAS, the Office of the Treasurer submits for review and approval FY2007 Budget**  
4 **Amendment No. 3; and**  
5 **WHEREAS, line item 610 Salaries is decreased by \$16,452.73, line item 620 Fringe Benefits is**  
6 **decreased in the amount of \$5,100.34 for a total decrease of \$21,553.07 and**  
7 **establishing line items for 710 Utilities in the amount of \$1,334.00, 721 Other Supplies**  
8 **in the amount of \$6,112.90, 722 Program Supplies in the amount of \$5,700.55, 730 Dues**  
9 **& Subscriptions in the amount of \$746.35, 751 Lease/Rentals in the amount of**  
10 **\$3,159.27, and increasing line items 771 Repair & Maintenance Vehicle in the amount**  
11 **of \$500.00 and 778 Alterations and Renovations in the amount of \$4,000.00 to the**  
12 **FY2007 Office of the Treasurer Budget; and**  
13 **WHEREAS, the FY2007 Office of the Treasurer Budget Amendment #3 has been reviewed by the**  
14 **Budget and Finance Committee.**  
15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
16 **the Office of the Treasurer Budget Amendment No. 3 and authorizes the following: line**  
17 **item 610 Salaries is decreased by \$16,452.73, line item 620 Fringe Benefits is decreased**  
18 **in the amount \$5,100.34 for a total decrease of \$21,553.07 and establishing line items**  
19 **for 710 Utilities in the amount of \$1,334.00, 721 Other Supplies in the amount of**  
20 **\$6,112.90, 722 Program Supplies in the amount of \$5,700.55, 730 Dues & Subscriptions**  
21 **in the amount of \$746.35, 751 Lease/Rentals in the amount of \$3,159.27, and**  
22 **increasing line items 771 Repair & Maintenance Vehicle in the amount of \$500.00 and**  
23 **778 Alterations and Renovations in the amount of \$4,000.00 to the FY2007 Office of the**  
24 **Treasurer Budget.**  
25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
26 **Nation's Officials, to wit: the Chairwoman and any designated official are authorized**  
27 **to administer the budget, provided however, that any amendments affecting the funds**  
28 **or funding levels of the budget shall be submitted for further prior approval by the**  
29 **Tohono O'odham Legislative Council.**


