

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY2007 with the Law Office of James D. Hill)**

RESOLUTION NO. 07-252

1 **WHEREAS, the Office of Attorney General requires additional attorney staff to properly fulfill its**
2 **functions; and**

3 **WHEREAS, James D. Hill, an attorney with twenty-two years of experience in the field of Indian**
4 **law, is available on a contract basis to work approximately half time to assist the**
5 **Office of Attorney General; and**

6 **WHEREAS, the Office of Attorney General has proposed an attorney contract with James D. Hill**
7 **for a budgeted amount of \$55,000.00 for the remainder of fiscal year 2007; and**

8 **WHEREAS, the Domestic Affairs Committee and the Budget & Finance Committee have reviewed**
9 **the attorney contract and recommend approval by the Legislative Council; and**

10 **WHEREAS, the funding for this Attorney Contract will come from the budget of the Office of**
11 **Attorney General (01-1031-810), which has sufficient funds for the contract amount.**

12 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 13 **1. The Tohono O'odham Legislative Council approves the Attorney Contract**
14 **with the Law Office of James D. Hill in the amount of \$55,000.00 for the**
15 **period ending on September 30, 2007, substantially in the form attached**
16 **hereto.**
- 17 **2. Funding for the Attorney Contract shall be provided from the budget of the**
18 **Office of Attorney General (01-1031-810).**
- 19 **3. The Chairperson of the Nation is authorized and directed to execute the**
20 **Attorney Contract.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
22 **of MAY, 2007 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of**
24 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
25 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
26 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
